ISB&M School of Technology, Pune an entity incorporated/registered under the provisions of the 'Maharashtra State board of Technical Education', having its registered office at Pashan - Sus road, Pune, (hereinafter referred to as "**ISB&M School of Technology**" which expression shall mean & include unless repugnant to the context or meaning thereof, its successors & permitted assigns) of the Other part

IDP Education India Pvt Ltd, Pune & ISB&M School of Technology, Pune are hereafter referred to individually as "Party" and collectively as "Parties".

PREAMBLE:

IDP Education Helps international students gain admission to education institutions in the main English-speaking countries

WHEREAS ISB&M School of Technology is a leading educational institute affiliated to AICTE & MSBTE, India, offering courses in Engineering Degree.

WHEREAS IDP India, Pune Services include personalised course advice, course application submission and pre-departure guidance



WHERE AS ISB&M School of Technology has shown readiness to collaborate with IDP Education, Pune for promoting the overseas studies & to provide all required infrastructure & facilities for running & conducting the various Seminars/ Events from time to time throughout the whole academic year as and when required.

NOW THEREFORE in consideration of the foregoing & mutual covenants and promises contained herein the Parties agree as follows:

1. It is agreed between the parties that IDP Education, Pune & ISB&M School of Technology shall work together on **non-exclusive** basis for the IDP Education, Pune courses mentioned hereof.
2. Role & responsibilities of each party will be as under:

Role & Responsibilities of IDP Education, Pune:

- Conducting education fair once or twice a year where US, UK , New Zealand , Canada and Australia Universities representatives will participate
- Conducting Seminars on IELTS & Overseas Studies
- Inviting ISB & M students to all education fairs @ Pune

Role & Responsibilities of ISB&M School of Technology INSTITUTE:

- Allow students of ISB&M School of Technology to attend the various events/ Seminar.
- To render all required support to IDP Education, Pune in conducting events
- To arrange & provide required infrastructure & facilities like:
 - Permission to post IDP education, Pune club event posters in college & hostel premises
 - Dedicated notice board / space in common notice board in college & hostel premises
 - Permission for using classroom/ Seminar hall (typically 1-2 times a semester during post-college hours for conducting Events/ Seminar/ one to one session)
 - Permission to use auditorium (typically 3-4 times a year for large scale programs)
 - Dedicated LCD Projector (if possible)
 - Tables & Chairs

Term of MOU:

This MOU comes into force from the day of signing by the last party. The term of this MOU is lifetime from the last party signing hereof. Either party may terminate this MOU



by giving thirty (30) days prior written notice to the other party.



Limitation of liability:

In the event of the occurrence of such dispute, either Party may, by written notice to other Party, have such dispute referred jointly to the authorized representatives of the Parties, or their successors or counterparts, for resolution by good faith negotiations within 15 days after such notice is received in respect of such dispute.
