OBJECTIVES OF THE MOU

The objective of this Memorandum of Understanding is:

1. PROPOSED MODES OF COLLABORATION

- c. Company will offer summer/winter Internship to interested students of **ISB&M School of Technology** at their company/project location so that students gets hands on experience of live project. (If Applicable)

- d. The number of students those can be considered for internship would be as mutually decided between **Encryption Infotech** and of **ISB&M School of Technology**.
- e. Company will provide IPR Guidance to students of **ISB&M School of Technology**.
- f. All the activities through this MoU will be non-commercial.
- g. Company will provide the placement assistances after completing the training course satisfactorily. Each party will appoint one Nodal Officer to periodically review and identify ways to strengthen the students. (If Applicable)
- h. The Memorandum of Understanding will take effect from the date it is signed by representative of the parties. It will remain valid for 3 years and may be continued thereafter suitable review and agreement.
- i. Any other appropriate mode of interaction agreed upon between **ISB&M School of Technology** and **Encryption Infotech**.
- j. Either party may terminate the MOU by giving written notice to the other party one month in advance.

2. CONFIDENTIALITY

- a. During and for a period of three (3) years from the date of disclosure, each party agrees to consider as confidential all information disclosed by the other party in written or tangible form or, if orally disclosed confirmed in writing within thirty days of disclosure and identified as confidential by the disclosing party.
- b. Once terminated neither **Encryption Infotech** nor **ISB&M School of Technology** Will ensure that all activities in progress are allowed to be completed successfully.
- c. This MOU is signed in subject to approval of the respective academic administrative bodies.

3. TERMS AND TERMINATION

This MOU, unless extended by mutual written agreement of the parties, shall expire 3 years after the effective date specified in the opening paragraph. This MOU may be amended or terminated earlier by mutual written agreement of the parties at any





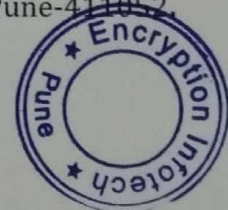
